Development students learn the cornerstones of early education through a variety of courses that study how children grow and develop, behavior guidance, planning meaningful curriculum experiences, and how to communicate with and engage families.

### The following Child Care and Development curriculum from Certificate to Associate is stackable.

- Child Development Associate of Applied Science (AAS) (60 hours)
- Child Development Certificate (C1) (30 hours)

### Special Admissions Requirements for All Child Care and Development Majors:

Because the criteria for child care center volunteers is determined by the Texas Department of Family and Protective Services (TDFPS) Minimum Standards for Day Care Centers, there are special requirements for enrollment in child development courses with fieldwork components. Students enrolled in these courses will be required to complete a criminal history statement and a notarized affidavit of this statement on the first day of class. The information will be submitted for verification by the Texas Department of Family and Protective Services (TDFPS) for a criminal history background check. Prior to participating in the course fieldwork component, all background checks must be verified as approved. Students who have lived outside the state of Texas in the past five years will also be required to do a FBI check. The cost for submitting all initial TDFPS forms are paid by ACC.

Students with any criminal history should refer to the Child Care and Development department website for more information or contact the Child Care and Development department to determine if they will be allowed to take child development courses or if a risk assessment is needed. Students should plan on beginning the risk assessment process, which must be completed with the Austin Community College Children's Laboratory School, three months prior to enrolling in child development courses. Contact the Child Development department at 512-223-5201 or the Director of the Children's Laboratory School at 512-223-5200 for more information.

#### Other Special Requirements for Child Development:

- 1. Students must receive a C or above in each child development course for the courses to be accepted toward the Certificates or Associate of Applied Science Degree.
- 2. Most courses have a fieldwork component. The majority of the fieldwork needs to be completed in a setting where young children spend their day. Students will need to be available to conduct the fieldwork requirements during daytime hours.

### **Career Information**

#### **Child Care provider**

The Child Care and Development program prepares students to work directly with young children ages birth-5 years old. Students completing a CDA, Certificate or an Associate's degree have options to work in childcare centers including non-profit, corporate, or family-home centers as a teacher or director. Other career options are preschool curriculum coordinator, early care home visitor, nanny, family day home provider and owner of a child care center. Graduates may also work in Head Start and Early Head Start. Centers are increasingly requiring staff to gain formal knowledge and skills to improve quality standards within their centers.

Child Care Workers, Education Administrators, Preschool and Childcare Center/Program, Preschool and Childcare Center/Program, Toddler Teacher, Nannies

#### **Regional Labor Market Information**

Childcare Workers: New workers generally start around \$15,517. Normal pay for Childcare Workers is \$19,690 per year, while highly experienced workers can earn as much as \$26,756. Over the last year, 95 companies have posted 596 jobs for Childcare Workers in this region. There are currently 10,427 Childcare Workers that are employed in Austin-Round Rock, TX.

Over the last year, 35 companies have posted 310 jobs for Education Administrators, Preschool and Childcare Center/Programs in this region.
